⌚ Purpose	<ul style="list-style-type: none"> <li>⌚ To increase the repertoire of skills and the capacity of agencies working with children and families to respond respectfully, flexibly, and constructively to situations in which concerns arise regarding child safety or family stability</li> <li>⌚ To embed these skills and this capacity within agencies serving children and families</li> </ul>	<ul style="list-style-type: none"> <li>⌚ To increase the repertoire of skills and capacity of community members, including lay persons and professionals, to respond respectfully, flexibly, and constructively to situations in which concerns arise regarding child safety or family stability</li> <li>⌚ To embed these skills and this capacity throughout the community</li> </ul>
⌚ General Definitions	<ul style="list-style-type: none"> <li>⌚ Person working in a paid capacity for a school, agency, or organization who is trained as a Family Team Meeting facilitator primarily for use within that school, agency, or organization.</li> </ul>	<ul style="list-style-type: none"> <li>⌚ Professional or lay member of the community trained as a Family Team Meeting facilitator with the intention of occasionally (or more often, if desired) making self available to facilitate Family Team Meetings for families identified by community members as experiencing risks related to child safety or family stability OR</li> <li>⌚ In-House Family Team Meeting facilitator whose agency has made that facilitator available for a specific situation or situations OR</li> <li>⌚ In-House Family Team Meeting facilitator who chooses to make themselves available, on their own time, for community-referred Family Team Meetings.</li> </ul>

<ul style="list-style-type: none"> <li>⌚ Use of Meeting Skills</li> </ul>	<ul style="list-style-type: none"> <li>⌚ In-house, for families agency normally serves</li> <li>⌚ In-house, for other situations falling within agency's mission</li> <li>⌚ Within community, if agency deems this to be an appropriate use of time</li> <li>⌚ Within community, on own time, in situations not falling within job or agency mission</li> </ul>	<ul style="list-style-type: none"> <li>⌚ Upon request and based upon own availability, will facilitate Family Team Meetings for families identified by community members as experiencing risks related to child safety or family stability</li> </ul>
<ul style="list-style-type: none"> <li>⌚ Payment*</li> <li>⌚ Fee not yet established, but will be an inclusive flat fee, paid by Boost4Families, for facilitator preparation time with participants, meeting facilitation time, any written meeting summary or family agreement, and travel time/cost.</li> </ul>	<ul style="list-style-type: none"> <li>⌚ No payment for facilitating meetings with families with whom the school, agency, or organization is already working</li> <li>⌚ No payment for using FTM to resolve situations which would normally fall within the mission of the school, agency, or organization</li> <li>⌚ Fee paid to agency, upon request, when facilitator is "loaned" to another school, agency, or organization to facilitate a meeting involving a family experiencing risks related to child safety or family stability</li> <li>⌚ Fee paid to individual, acting on own time, when authorized by Boost4Families to respond to a community request for FTM facilitation</li> </ul>	<ul style="list-style-type: none"> <li>⌚ Fee paid to individual, acting on own time, when authorized by Boost4Families to respond to a community request for FTM facilitation</li> <li>⌚ Fee paid to school, agency, OP organization, upon that organization's request, when an In-House facilitator is "loaned" as a Community FTM facilitator, and when Boost4Families has approved the family situation as appropriate for use of FTM funds.</li> <li>⌚ Fee may be waived by community FTMs facilitators or agencies</li> <li>⌚ Agencies may elect to "swap" facilitation time with each other in lieu of seeking authorization and payment from Boost4Families</li> </ul>
